3. Attach the official transcripts of the 2 semester hours of credit required for renewal of the Substitute Authorization. These credits may be completed for staff development credit from an Iowa Area Education Agency or undergraduate or graduate college credit from a regionally accredited institution.
4. Renewal requirements for the substitute authorization include verification of completion of a mandatory child and dependent adult abuse class approved by the state abuse education review panel. Please submit a photocopy of the certificate that you received upon completion of the course. The class must have been completed within the past five years.
5. Please allow four weeks for processing.

*Name changes require a photocopy of official legal documentation. **All fees are NONREFUNDABLE. Incomplete applications will be voided after 45 days.**
